### Our services include

- **Construction and real estate law:** project structuring and packaging in accordance with the German Sector Ordinance (Sektorenverordnung or SektVO), structured financing (leasing und contracting), construction site safety and construction employment law, project manager and planner agreements and agreements with operating companies, contract management and anti-claim management, lease and rental agreements, out-of-court conflict resolution and partnering
