Ziel des Seminars ist es, das Handwerkszeug für die Anwendung der De-minimis-Vorschriften im EU-Beihilferecht zu vermitteln. Nach einer kurzen Heranführung an die Thematik werden typische Anwendungsfälle besprochen, wobei der Fokus auf der allgemeinen De-minimis-Verordnung und der DAWI-De-minimis-Verordnung liegen und auf Änderungen durch die Novellierung zum 01. Januar 2024 eingegangen wird. Dem schließen sich Erläuterungen zum Umgang mit Fehlern bei der Anwendung der De-minimis-Vorschriften und Lösungsansätze an. Abschließend wird überblicksartig auf die Möglichkeiten der Gewährung von Beihilfen außerhalb der De-minimis-Vorschriften eingegangen. Ob Schwimmbäder, Schulsport oder Mehrzweckhallen - der Sanierungsstau wird in den nächsten Jahren erhebliche finanzielle Maßnahmen der deutschen Kommunen erfordern. Mit Programmen wie dem Bundesprogramm „Sanierung kommunaler Sportstätten“ und der geplanten Sportmilliarde stehen hierfür erhebliche Bundesmittel zur Verfügung. Zugleich stellen diese Förderungen Kommunen vor komplexe beihilferechtliche Fragestellungen. Dieses Seminar vermittelt Ihnen kompakt und anwendungsorientiert die aktuellen Anforderungen des EU-Beihilferechts bei der öffentlichen Finanzierung der Sanierung und Neuerrichtung von kommunalen Sportinfrastrukturen. Im ersten Teil des Seminars wird der Beihilfegriff hinsichtlich der Tatbestandsmerkmale „wirtschaftliche Tätigkeit“ und „Auswirkungen auf den zwischenstaatlichen Handel“ vertieft besprochen und Lösungsmöglichkeiten aufgezeigt, Förderungen außerhalb des Anwendungsbereichs des EU-Beihilferechts zu gestalten. Kann der Beihilfecharakter eine Förderung nicht ausgeschlossen werden, kann eine Förderung als De-minimis-Beihilfe, über eine DAWI-Betrachtung und über eine AGVO-Freistellung (Art. 55) gewährt werden. Die Anforderungen an diese Gestaltungsmöglichkeiten und die Herausforderungen in der Praxis bilden den zweiten Teil des Seminars. Die Veranstaltung ermöglicht es den Teilnehmenden, potenzielle Beihilferisiken rechtzeitig zu erkennen, rechtssicher zu bewerten und geeignete Lösungsstrategien zu entwickeln. Das Seminar ist eine Kooperationsveranstaltung von GIBT Colleg e. V. (Veranstalter) und dem Kommunalen Bildungswerk e. V. GIBT Colleg e.V. und KBW e.V. stehen für die handlungsorientierte Vermittlung anspruchsvoller Fachthemen in der beruflichen Praxis.
